[PROPOSED] JUDGMENT 1 2 Plaintiffs Universal City Studios Productions LLLP, Universal City Studios LLC, Universal Television LLC, Universal Content Productions LLC, DreamWorks 3 Animation LLC, Disney Enterprises, Inc., Paramount Pictures Corporation, Amazon 4 5 Content Services LLC, Apple Video Programming LLC, Warner Bros. Entertainment Inc., Netflix US, LLC, Columbia Pictures Industries, Inc., and Screen 6 7 Gems, Inc. (collectively "Plaintiffs") brought this action against Dwayne Anthony Johnson d/b/a ALLACCESSTV and Quality Restreams ("Defendant") on December 8 9 2, 2021. 10 Plaintiffs and Defendant have stipulated to judgment and a permanent injunction. 11 IT IS ORDERED, ADJUDGED, AND DECREED AS FOLLOWS: 12 Judgment is entered for Plaintiffs and against Defendant for 13 [1] infringement of the Copyrighted Works. 14 15 [2] Damages are awarded in favor of Plaintiffs and against Defendant, in 16 the total amount of thirty million dollars (\$30 million).
